1. Programme Aims and Objectives

The Visual Arts Practice programme provides mature students with an opportunity to experience the potential of visual arts practice through sustained engagement with materials, techniques, processes and disciplinary contexts. Students are encouraged to draw on their experiences to generate ideas and become involved with developments in contemporary visual arts.

The aims of the programme are to:

- Explore ideas and apply problem solving approaches to visual arts and design,
- Demonstrate experimentation with materials,
- Acquire knowledge and skills in a disciplinary domain,
- Examine theories and ideas underpinning contemporary visual arts practice.

The objectives of the programme are to:

- Encourage students to explore ideas and processes as part of an evolving practice,
- Develop appropriate research skills and apply to practice,
- Examine ideas and theories and relate these to an emergent practice,
- Develop a reflexive approach to project work,
- Plan and carry out a project,
- Communicate effectively ideas underpinning your studio work.

2. Programme Outcomes

On successful completion of the programme, students will be able to:

- Explore a range of materials and techniques and apply to practice,
- Research and select appropriate materials for project work,
- Demonstrate a research methodology and apply to practice,
- Translate ideas from notebooks into project proposals,
- Apply conceptual skills in the realisation of projects,
- Present a coherent body of work for display,
- Critically analyse key concepts and ideas in visual culture,
- Locate an emerging practice in the context of contemporary visual arts practice.

Graduating students will be able to work independently, participate in group exhibitions and organise small group shows. They will be able to communicate the ideas informing their work effectively to peers and locate their emerging practice within contemporary visual arts practice.

3. Admission Requirements

The programme is open to mature students who have turned 23 on or before 1 January of the year in which they wish to commence study on the programme, and who have experience in art, design, or photography either from completing a summer or short course at NCAD, or completing a module on the Visual Arts Practice programme as audit only, or have similar experience. Leaving Certificate or FETAC or equivalent is a requirement for entry.

To apply for entry to the programme, applicants must complete a written application form. Applicants must also demonstrate that they will be able to manage the academic writing elements of the programme.

Applicants may also submit a portfolio to have previous learning or experience recognised (RPL) to fulfil entry criteria. Students can also apply for recognition of prior learning for any of the modules, to a maximum of 10 credits of the programme.

4. Further Educational Opportunities

Students who successfully complete the Visual Arts Practice programme can apply for entry to the part-time Diploma in Art & Design. Successful completion of the Diploma allows graduates to apply for Higher Diploma in Art & Design (planned for 2019), which in turn provides an opportunity for successful students to apply for entry to Stage 3 of NCAD BA in Fine Arts.

5. Teaching and Learning Methodologies

Students will engage in blended and face to face learning. Use of digital learning interface such as google classroom will feature as part of the learning experience and knowledge of and use of computers will be embedded in the learning experience. Small group critiques, individual presentations, peer learning and group display of final project work, feature within the programme. Teaching and learning strategies

include; lectures, demonstrations, seminars, as well as group discussion. Studio critiques and student presentations will encourage dialogue, peer learning and active participation amongst students.

In the early stages of the programme student led presentations, combined with participation in small group critiques, will facilitate students to gain confidence and enhance their communication skills. Critical and analytical skills will be enhanced as the course progresses through; research, experimentation and application to practice.

6. Methods of Assessment

The programme uses both summative and formative assessment throughout each module, to ensure students are well informed of their progress. Summative assessment contributes to final results of a module, whereas formative assessment provides more immediate advice on student's progress, and identifies where students need to focus more effort.

Review of students progress are scheduled throughout each module with formal assessment at the end of a module, to ensure workload is spread evenly across the programme. Each assessment is focused on the achievement of the module learning outcomes. Students will receive verbal and written feedback and their work will be graded using NCAD's grade descriptors. Results are communicated to students as an alpha grade (A+ to D- are passing grades).

Assessment tasks vary, depending on the module. Studio practice modules involve; projects, drawings, animation, video, paintings, artefacts, sculpture, installation, group critiques and student-led presentations. Final assessment includes displaying studio project works. Assessments in the Visual Culture module will include where practicable a review of an exhibition or other art event, and a written assignment.

7. Programme Review and Evaluation

It is important to NCAD that students inform the development of teaching and learning at NCAD. We encourage all students to communicate their concerns and their observations about their study to members of staff so that any changes can be made in a timely manner.

About two-thirds of the way through the trimester, a student forum will be convened to gather students' comments about their study and the delivery of the programme. In addition, at the end of the spring trimester, students have the opportunity to complete an online evaluation of their study and experience at NCAD. These evaluation events are important to current and future students, to ensure we can enhance the delivery of programmes at NCAD.

In addition, you are invited to discuss your experience on the module with your lecturers at any point during the year. You can also relay your comments to the class student representative who will communicate your comments to the staff.

8. Modular Provision

Students complete *CEAD1001 Theories and Concepts in Critical Cultures* and *CEAD1002 Professional Practice 1* (5-credit core modules), and select two 10-credit studio-based modules, one from each of the following two groups:
