1. Introduction

This module focuses on the development of skills and knowledge applicable to the formation of a professional practice and identity.

The aims of this module are:

- Provide an introduction to library resources and appropriate use of library facilities to inform research and practice.
- Develop students' confidence in the use of research resources online and face to face through library facilities.
- Establish ways of working appropriate to and applicable to professional practice.
- Develop a knowledge of gallery and cultural resources and how they relate to the development of professional practice.
- Be able to critique methods and ideas.

2. What will I learn?

On successful completion of this module students will be able to:

1. Use library facilities to undertake research and apply to assignments.
2. Recognise a range of cultural resources including: galleries, museums, shops/informal display spaces and assess such facilities in the formation of an emergent practice.
3. Display project work to peers and other selected audiences.
