1. Introduction

This module focuses on the development of skills and knowledge applicable to the formation of a professional practice. The module concentrates on the acquisition of skills and competency in the use of materials in painting. Students are encouraged to examine developments in contemporary art practice and become acquainted with a range of galleries and museums.

The aims of this module are to:

- Generate ideas and expand on these for project work.
- Explore a range of themes using library resources and notebooks.
- Document the research process and compile notebooks as a resource.
- Practise technical skills in drawing and painting.
- Produce a number of drawing and paintings.
- Participate in small group discussion and peer learning.

2. What will I learn?

On successful completion of this module students will be able to:

- 1. Define colour theory and apply to project work.
- 2. Engage with formal and conceptual problems as part of a project.
- 3. Experiment and use competently oils, acrylic based paints.
- 4. Write a project outline and create a body of work.
- 5. Select appropriate research materials for project work.
