1. Introduction

This module explores the processes central to the concept of drawing as investigation and a tool for discovery within contemporary art practice.

The aims of this module are:

- Equip students with drawing skills applicable to practice.
- Develop students' confidence to explore drawing outside of traditional approaches.
- Establish ways of working applicable to professional practice.
- Develop research skills on a sustained drawing practice that is driven by a curiosity to follow an idea through.
- To learn good decision making applicable to practice.

2. What will I learn?

On successful completion of this module students will be able to:

1. Demonstrate skills in drawing using a range of materials and approaches.
2. Present drawings and related notebook investigations to their peers.
3. Describe a – personal - approach to drawing and investigation.
4. Illustrate the potential of drawing to investigate ideas and sustain project work.
5. Demonstrate evaluation skills and a reflective practice: To learn how to develop a definite line of enquiry.
6. Know how to make connections and link ideas in their practice.

7. Develop an awareness of contemporary art practice to inform and contextualise their work.

3. How will I learn?

- One-to-one tutorials.
- Studio practice – students work in the studio amongst their peers and tutors.
- Group critiques and evaluations.
- Self-directed study and sustained practice outside of studio time.
- Research in the NCAD Library.
- Visiting Lectures inform and enhance learning opportunities.
- Working towards assessment at end of Trimesters one and two. The deadlines are beneficial as a goal to work towards.
- Students will work with experienced tutors on this course. This range and scope of knowledge facilitates learning.

4. What learning supports are provided?

- Students have contact hours twice a week with programme tutors
- The tutors may be contacted by students via email
- Students have support from experienced tutors. This range and scope of knowledge facilitates the learning greatly.
- The course structure, fosters cohesion and supports peer learning
- The students are aware of the progression within CEAD.
- Students undertake a library tour, where tutors help students to research contemporary art so that they can refer to it in their work.
