1. Introduction

In the first year of the higher diploma students are required to undertake a disciplinary project to explore and research a disciplinary area.

The aims of this module are:

- 1. Introduce students to a range of materials and media,
- 2. Engage in a series of sequential workshops related to 2D studio,
- 3. Expand students' understanding of the interdisciplinary aspects of their chosen discipline,
- 4. Acquire technical skills and knowledge applicable to painting and expanded practice.

2. What will I learn?

On successful completion of this module students will be able to:

- 1. Demonstrate technical knowledge and skills applicable to studio practice.
- 2. Apply technical knowledge of painting techniques and lens-based media to studio project.
- 3. Articulate multiple perspectives on painting as a medium within contemporary practice.
- 4. Investigate painting and expanded practices through a series of workshops.
- 5. Analyse ideas underpinning art within the public realm.
- 6. Critically assess how painting and expanded practices are framed.

3. How will I learn?

Through a series of sequential practical workshops in studio that focus on skills and ideas development relevant to current to discourse in contemporary fine art practice. Workshops will be

practical, discursive with opportunities for students to actively engage with the tutor. On-going tutor feedback in response to student questions features within the module learning context.

Students will draw on experiences from the work place and their lived experiences to inform their research and learning. Student will conduct group discussions to explore and document work based learning and its relationship to a formative art practice.

Studio demonstrations, tutor-led demonstrations and workshops with tutorial support.

Students will receive a written brief and assessment guidelines from the module tutor at the outset of the module. Students are required to present their work to their peers and participate in a critical review of their progress.

Students will present work at the end of the module and final submission of portfolio work will be assessed at the end of the trimester.

The two assessment tools will assess all six learning outcomes holistically.

Students' assessments will be graded using the NCAD Grade Descriptors.

Students can expect written and verbal feedback on assessment outcomes.

9. How will I have the chance to evaluate the module?
