1. Introduction

This module focuses on the development of knowledge of critical cultures through research and analysis of texts and visual imagery.

The aims of this module are to:

- Introduce key concepts and ideas underpinning visual culture and contemporary art practice.
- Encourage students to examine ideas and theories related to cultural practices in the modern period.
- Relate theories and ideas in modern and contemporary visual art and design practice to their emergent practice.
- Become familiar with a range of cultural resources, gallery spaces and museums.
- Produce written assignments showing depth of research.
- Contribute to discussion and seminar based presentations.

2. What will I learn?

On successful completion of this module students will be able to:

- 1. Critically assess key concepts underpinning critical cultures.
- 2. Appraise a number of theories informing visual and critical cultures in the modern/postmodern era.
- 3. Identify key phases in modern and contemporary culture.

- 4. Summarise different perspectives on the role of the museum and gallery as a site for presentation and display.
- 5. Integrate theories within an emergent practice.
