#### 1. Introduction

This module requires students to establish a practice-based inquiry with selected participants or publics through experimentation with individual and collective methods of socially-engaged art practice. Each student will research and scope their own inquiry (or, should they wish, in partnership with another student on the programme). They will also determine the extent and the nature of the participation with communities, individuals or organisations, learning through action and reflection.

As a 10-credit module, conducted over a trimester, it is important to note that the Practice in Public module is designed to support 'experiments' rather than fully-resolved projects. These include experiments with form and methods of engagement with communities/publics (eg hosting a banner making workshop, staging an artistic intervention on the street, organising an alternative walking tour) as well as experiments with site and modes of documentation. As such the 'in public' element of this work may take the form of a proposition, or a short scale intervention into a public setting, or modest forms of co-creation with others. The peer to peer learning that is made possible through shared reflection on students' experiments will be nurtured here.

To inform and support their practice-based experiments, this module is structured around a series of talks from visiting lecturers (national and international) and practical skills workshops where students will be introduced to diverse approaches to engaging participants and publics in their practice, and key skills necessary to the development of social interactions considering how to effectively enter, engage and exit diverse social contexts.

A practice of critical reflection is of central importance, as students are supported to reflect upon their experiments considering challenges related to ethics, power relations, positionality and knowledge production. In this, they will be supported to make a proposal and to present their work at a mid-point to their peers and staff.

The aims of this module are to:

- Ensure that students have a sophisticated and critical understanding of potential and limits of socially-engaged art practice
- Provide learners with opportunities to engage with and critically reflect on different models of practice of socially-engaged artists, while developing their own practice
- Support in the design of a sophisticated and well informed socially-engaged project which can be tested in public
- Develop a sophisticated understanding of the techniques, understanding and skills required to document practice

#### 2. What will I learn?

This module features workshops and other classes concerned with understanding diverse approaches to socially-engaged art practice by means of presentations with practitioners, and with developing key skills.

The themes of key skills workshops will include *facilitation* (i.e. how to work with different individuals and communities in inclusive ways that allow for different perspectives and needs to be articulated and shape outcomes), *group work* (i.e. how to manage differences of opinion and how to organise groups with diverse skills, needs and levels of engagement and to act together) and *communications* (i.e., how to communicate with different stakeholders in ways that meet good standards of plain expression and are sensitive to cultural differences). Particular emphasis will be placed on developing the skills and techniques required to *document practice* – in terms of project design, social engagement and public realisation. This includes critical reflection on the ethics of authorship and documentation (consent, open access, etc.)

The learner will secure opportunities to test these key skills and approaches by developing an inquiry of their own devising, engaging with communities and other social actors as necessary.

On successful completion of this module, students will be able to:

- 1. Scope an inquiry which is capable of being realised 'in public'
- 2. Engage in facilitation and other forms of social engagement
- 3. Apply the principles and ethical frameworks required for meaningful and just engagement with different communities.
- 4. Document practice in sophisticated ways that allow for public dissemination.

#### **Module content**

The module will combine lectures and seminars led by the Art and Social Action team as well as socially-engaged art practitioners. Students will make site visits, engage in workshops related to the assessment task and undertake group work.

## 4. What learning supports are provided?

#### 6. How will I be assessed?

The assessment task will take the form of a presentation in which students will demonstrate critical reflection on the ethical and practical elements of engaging in creative practice in partnership or close relations with civic society. It will be assessed using the College's published grade descriptors and written feedback will be given to the students.

### 7. Feedback, results and grading

Students will receive written feedback on completion of assignments. Assignments will be graded using the <u>NCAD Grade Descriptors</u>.

#### 8. What happens if I fail?

Resit opportunities will be provided. Opportunities to remediate an unsuccessful assessment depend on the deficit encountered. Resit opportunities will be provided at the end of each trimester to students who do not complete all assessments by the assessment deadline. Students who are unsuccessful at Week 4 and 11 for continuous assessment assignments worth 75% of module may be given the opportunity to resit each element during the 15 weeks of the module. This will not involve a resit fee. Students who are unsuccessful at Week 15 for the single assignment worth 25% of module may be given the opportunity to resit for the next exam board. This will involve a resit fee.

A student failing substantially at both continuous assessment and the final 25% assignment would be required to repeat (and attend) the module in the following year, and pay the required registration fee.

## 10. How will I have the chance to evaluate the module?

It is important to NCAD that students inform the development of teaching and learning at NCAD. We encourage all students to communicate their concerns and their observations about their study to members of staff so that any changes can be made in a timely manner.

About two-thirds of the way through the year, a student forum will be convened to gather students' comments about their study and the delivery of the programme.
