1. Introduction

This module forms a 5 credit capstone module for the Professional Diploma in Art and Design Research. Students undertaking this module will have developed a critical understanding of research methods and issues in three taught modules. This module presents an opportunity to further develop and deploy that understanding by undertaking a task which requires that the student produces a proposal for a research-related activity that is capable of successfully passing an external peer-review process.

This will be one of the following

- i. An application proposal for a research project (such as an application to undertake a research degree at NCAD or another HEI);
- ii. An application proposal for research funding from a research organization (such as an application to the IRC or the Arts Council). This might be an application to secure support to undertake research or to organize a research dissemination event such as a conference or a symposium;
- iii. Proposal and preparation of a conference paper or similar for presentation at a scholarly event.

Students undertaking this module will be required to identify a context in which this proposal to an external body might occur (e.g. by identifying a suitable funding scheme or conference). They will be supported to follow the application process by close mentoring by a suitably qualified member of staff at NCAD.

At the outset of the module, a clear set of learning ambitions and schedule – in the form of a learning plan - will be articulated by the student and agreed by the NCAD team (including the CFA staff). Students will be supported to research good practice in the field that they have chosen to

develop as well as the intellectual, ethical and practical dimensions of making a proposal for funding and publication. If, for instance, a research workshop is to be proposed to generate interactions between participants, the student will be supported to research different workshop formats.

Feedback will be provided at different stages of the project – these may include draft abstracts, draft proposals, rehearsals of presentations, etc. Full documentation of the materials prepared for external peer review will be submitted for assessment. Successful competition of the module does not require that the paper is selected for publication; or that external funding is awarded.

2. What will I learn?

On successful completion of this module students will have achieved the following:

- 1. UNDERSTANDING of the peer review processes and criteria which operate in different fields of research funding / publication;
- 2. UNDERSTANDING of the current concerns and priorities of organisations and scholarly bodies in the student's field of practice;
- 3. COMMUNICATION of research plans and needs in a persuasive manner

3. How will I learn?

This module is taught by means of close mentoring. Students will be given one-to-one support by their supervisor or another member of NCAD staff in a series of tutorials and feedback sessions.
