## 1. Introduction

Art Practice Lab acts as an introduction to the various aspects of being a contemporary artist necessary to the establishment of an individual professional practice in fine art aimed at the further construction of an individual methodology that, whilst exploring various aspects of materials and processes, also frames these activities within the context of a range of networks of distribution both in and beyond the gallery.

The module requires developing a culture of practice-based testing of work and a negotiation of practice-based research. The thrust of this module is to establish a series of practice-based inquiries and to set in motion a culture of discovery through engagement with art making. The MFA tutorial report form tracks this inquiry, building a research tool into the practice project.

This module aims to:

- 1. Generate an experimental ability with materials and processes in order to advance relationships between the construction of meaning and personal motivation.
- 2. Enable students to be able to contextualise their practice within the area of Fine Art and the broader cultural field.
- 3. Develop the ability to edit and present intelligently the results of individual research.
- 4. Gain a working understanding of masters level participation

### 2. What will I learn?

On successful completion of this module students will be able to:

• Demonstrate an ability to experimentally develop processes and materials in an advanced manner appropriate to their particular inquiry.

- Test their ideas and approaches through their realisation in practice in relation to their ambition for their work.
- Reflect critically and objectively on their own practice with regard to contemporary and historical models of fine art practice.
- Establish an understanding of the challenges and scholarship of Masters Study in Fine Art.
