#### 1. Introduction

This practice-based module requires the student to develop a significant body of work, over two semesters, culminating in a public exhibition. As such it represents the outcome of two years of research and testing in the studio or appropriate context. In this module the student is encouraged to move towards the consolidation and synthesis of the various issues addressed within the form and content of their individual practice. It involves the student identifying the appropriate methods to make their work public, with awareness of contexts and audiences and negotiating the challenges of selecting, installing and exhibiting the work with available resources. At the mid-year point there is a summative assessment of the student's work supporting the consolidation of a major practice project with written feedback.

The aims of this module are to:

- Develop an advanced ability to integrate and synthesise their practice-based knowledge into an effective public form, ultimately an exhibition.
- Extend the student's practice into a public context and the communication of the ideas manifested within the work to an audience.
- Encourage the student's engagement with the relevant methods of production, display and distribution of their work.
- Facilitate the transition from education into the professional field of art practice with a
  desire to connect with the world at large and to specialist audiences.

#### 2. What will I learn?

On successful completion of this module students will be able to:

- RESOLVE formal and intellectual issues and concerns within their work in a convincing, knowing and challenging way through the use of appropriate skills, decisions and evolved research methods.
- 2. REALISE means of resolving their work through methodologies appropriate to recent developments in contemporary practice.
- NEGOTIATE the challenges of making the transition from studio-based research to a public dissemination format with awareness of the possibilities of extending the work through its public outcomes.
- 4. CONNECT with specialist and non-specialist audiences through professional dissemination of work which synthesises and integrates research and critical reflection.

#### 3. How will I learn?

Self-directed and directed practice-based research, group and individual tutorials, critical seminars, field work, Tutorial report portfolio. Teaching and Learning will be delivered in a blended approach including in studio / on line and off line.
