1. Introduction

This module focuses on key accounts of the politics of participatory and collaborative practices. Students will explore particular theories and key examples. Participatory practices are widely understood as a shift away from the static object-based notion of art practice toward an exploration of art as the indeterminate organisation of spatial relations between the artist and the public. Questioning the conventional divide between the artist and the audience, these practices also challenges assumptions about the role of the museum, the curator, and the critic.

The aims of this module are to:

1. Explore some key theoretical paradigms and practices that are most relevant to participatory and collaborative practices in Contemporary Art.
2. Critically analyse the relationships between students' own thought and practice and the strategies, apparatuses and theories of effective participation and collaboration.
3. Support students in developing a good knowledge of the practices, vocabularies, theories and figures that inform and influence contemporary participatory and collaborative practices.

2. What will I learn?

On successful completion of this module students will be able to:

1. RESEARCH: Demonstrate a working knowledge of the relevant paradigms and practices that are most relevant to participatory and collaborative practices in Contemporary Art.

2. ANALYZE: Apply critical perspectives on the relationships between their theory and practice and the strategies, apparatuses and theories of effective participation and collaboration.
3. COMMUNICATE: Successfully articulate and present (in various forms) a good knowledge of the practices, vocabularies, theories and figures that inform and influence contemporary participatory and collaborative practices.

Module content

To reflect the changing nature of contemporary theories, practices and debates relating participatory and collaborative practices the specific module content changes according to the themes that are deemed to be most relevant to the learning cohort at the time of delivery. At all times there will be careful consideration of the place and relevance of creative practices in the contemporary world.

In the past discussions have considered examples from early performance-based and conceptual art along with Artist Collectives and online works rooted in the multi-user dynamics of Web 2.0 platforms. The course will explore concepts such as: Participation and the 'other', Relational Aesthetics, Socially Engaged Practice, The Dialogical, Informal Pedagogical Practices and Utopian Politics.

3. How will I learn?

The classes are student centred discussions, group work and problem-based activities based on close analysis and critical reflection of key theoretical texts, positions and practices.
