1. Introduction

This module outcome is produced in relation to the final PGVC2004 Major Practice Project. It provides an opportunity to reflect on the aims and objectives of that project and communicate these to a wider audience. Students will present the focus, method and argument of their research in an appropriate medium to address a public. They may work collectively (for instance, in creating a publication) or individually. Students will be asked to write a short critical reflection on the form of the output as well as outlining the challenges in undertaking this task.

The aims of this module are to support students both individually and as a group to:

- 1. Identify the key foci, methodology and character of their practice as they relate to a research theme
- 2. Explore the key elements, techniques, strategies and mediums of their practice
- 3. Test and choose the most appropriate and effective modes of presentation that best articulate the overall themes of their expanded research-practice projects.

2. What will I learn?

On successful completion of this module students will be able to:

- 1. RESEARCH: articulate and present the themes and methodology of their expanded researchpractice projects
- ANAYLSIS: identify and explain the key elements, techniques, strategies and mediums of their practice
- 3. COMMUNICATION: Present the ideas at play and the ambitions of the work in appropriate and effective modes of presentation that connect with audiences, peers and stake-holders.

Module content

Content is student-centred and created by students with a view to making a publication presentation of their expanded research-practice projects.

3. How will I learn?

Students are supported by one-to-one tutorials as well as group tutorials in which potential approaches to publication / display will be considered tested and critiqued.
