#### 1. Introduction

Like Module VC1-1, the broad aim of this module is to provide an introduction to the images, objects and concepts that constitute major current issues in visual and material culture. And, like Module VC1-1, this comprises of two types of class — a series of weekly lectures and a regular weekly seminar. After the emphasis on identity which characterises the content on module VC1-1, this series of lectures and seminars focuses on a different but parallel set of themes including sustainability, the ethics of production, and the Anthropocene.

The seminar provides opportunities for the students to develop and test techniques of visual and textual analysis in a supportive context. It will usually be based on a single text which the student is required to read in advance, coming to class prepared for discussion of it. Some of these texts will be historical works by major philosophers of modernity. Others will offer a contemporary perspective. Emphasis will be placed on the effects and legacies of modernism/modernity in the present.

Students will submit an essay at the end of the trimester which will present an opportunity to critically reflect on the works and ideas which have featured in this module.

The aims of this module are to:

- Introduce students to key current themes and debates in art and design today.
- Introduce students to techniques of visual and object analysis.
- Provide opportunities to test concepts and theories.

#### 2. What will I learn?

On successful completion of this module students will be able to:

- 1. RESEARCH: research the major underlying concepts of modernism and modernity through original and secondary sources.
- 2. ANALYSE: analyse the claims made by proponents of modernism about the contribution of art and design to social progress.
- 3. COMMUNICATE: write effectively about the concepts and practices of modernity.

#### Module content

Lectures and seminars will address broad themes which are of common interest to all areas of art and design practice. Students will be introduced to key concepts and theories. The lectures will be illustrated with historical and contemporary examples of practice. Typical lecture topics include:

- Visions of Utopia and Dystopia in Art, Architecture & Design
- Tactical Media
- Imagining the End of the World: Nature, Culture, Apocalypse
- Cultural Labour
- Family Photography: Conventions and Subversions
- Utility
- Systems and Objects
- Fashion and Sustainability
- Excess
- Border Crossings: Territory / Displacement / Belonging
- Down with This Sort of Thing: Sexuality in Irish Art and Design
- Imagining the Nation

### 3. How will I learn?

Classes take the form of lectures followed by seminars in which students will have the opportunity to test and discuss the themes in the in the lectures. Dedicated seminars will address the assessment task of writing an essay.

### 8. What happens if I fail?

Opportunities will be provided during or at the end of Trimester 2 to students who do not complete all assessments in Trimester 1, but students will not be able to progress to the next stage of the programme until they have successfully completed all Year 2 modules, equivalent to 60 credits.

### 10. How will I have the chance to evaluate the module?
