Introduction

This module develops critical understandings of theories of design in their historic context. Rather than offer a survey course on the history of design practice, it encourages students to develop a keen understanding of the historical development of key analytical and interpretive tools for making sense of the material world. It approaches ideas as historical objects which are formed in particular material and intellectual conditions and have particular effects. Attention is not only placed on the historical text but also the media and cultural contexts in which it appeared. As such, it also examines the ways in which criticism and discourse shapes design / design practice and vice versa. Through the module, students examine when and how the activity of history writing can be a kind of critical intervention into the field. This affords engagement with both contemporary commentators and key historical texts. For instance a class on changing ideas about ornament in the C19th will involve reading Semper, Riegl and Loos as well as the work of historians like Ivesen. Other key design historiographic themes will include Iuxury (Veblen), mass production (Giedon), information (McLuhan), etc.

What will I learn?

On successful completion of this module students will be able to:

i. engage in close critical ANALYSIS of texts to understand how historical positions are consolidated and arguments made;

ii. CONTEXTUALISE historical arguments, demonstrating how ideas are themselves products of historical circumstances;

iii. PLAN, STRUCTURE and DELIVER a historiographic essay.

Module content

How will I learn?

Each class will take the form of a 2-hour seminar based on key readings. It will run over 10 weeks. Students will attend lectures and participate in seminars.
