#### Introduction

Through focussing on a particular thematic, for example a specific area of Dublin, this module focuses on the ways in which public understanding of design has been shaped by exhibition practices and other forms of public display. Moreover it understands exhibition design itself to be a fertile ground of design creativity, criticality and innovation. The module combines a historical examination of different exhibition forms (such as national pavilions at international exhibitions and world's fairs, skansens, homes of the future, on-line immersive and narrative formats, etc.) with the practical challenges of exhibition making today. It will examine recent curatorial practices such as Rapid Response Collecting at the V&A as well as other modes of display and mediation. The classes will feature contributions from curators working for our institutional partners (see module DHPG1).

Students, working collectively or in small teams, will be required to mount a real or virtual display using the facilities of (for example) the NCAD Gallery, NIVAL and/or the partner organisation. For instance, an exhibition may be of archival material and/or reproductions of 'original' material in Dublin collections / archives, or as illustrative of students' individual research undertaken as part of this module.

### What will I learn?

On successful completion of this module students will be able to:

- i. critically ASSESS the exhibitionary practices of museums and galleries;
- ii. UNDERSTAND the design historical changes in exhibition practices which have occurred since the late C19th;
- iii. DEVELOP and TEST curatorial techniques and skills by creating a real or virtual display;
- iv. COMMUNICATE ideas about design through modes of display.

#### **Module content**

# How will I learn?

Taught over 10 weeks, this module will combine two types of 3-hour class: i. lectures/seminars on 'exhibitions histories'; ii. workshops which result in the exhibition. Some of the workshops will be organised to develop particular professional skills such as exhibition text writing / interviewing. Students on the DHMC

programme will be encouraged to work with design students at NCAD (either on the design MA programmes or those attached to the Design Bureau).


# How will I have the chance to evaluate the module?
