## Introduction

This module is comprised of a range of elective seminars from which students pick 1. All electives are focused on a specific research area/ question. They address a variety of cultural and social contexts for art practice today. They also, frequently, concern the crossover between art and related disciplines. Key features of *Situations* include: (i) seminars on specific research interests of contributors; (ii) invited/ guest contributions; (ii) collaborative initiatives with other institutions.

In the past seminars have included topics such as Systems Aesthetics; Art & Literature; Art and Ecology; and collaborations with Irish Film Institute; Irish Museum of Modern Art; The Joinery (a not for profit gallery.)

#### What will I learn?

On successful completion of this module students should be able to:

- 1. RESEARCH: research material, questions and practices related to the specific module material;
- 2. ANALYZE: the seminar material and relate it to the broader contexts of (i) contemporary art and (ii) the student's own practice and research concerns
- 3. COMMUNICATE: Communicate the relevance of the specific research questions to their own and others' practices.
