Introduction

This module outcome is produced in relation to the final Major Practice Project (module code). It provides an opportunity to reflect on the aims and objectives of that project and communicate these to a wider audience. Students will present the focus, method and argument of their research in an appropriate medium to address a public. They may work collectively (for instance, in creating a publication) or individually. In both cases, students will be asked to write a short critical reflection on the form of the output as well as outlining the challenges in undertaking this task.

What will I learn?

On successful completion of this module students will be able to:

- 1. IDENTIFY the key focus, methodology and character of their practice
- 2. CONNECT with a public through appropriate channels
- 3. ARTICULATE the ideas at play and the ambitions of the work into an appropriate form with a contemporary awareness of the potentials and conventions of the form.

Students will be supported with one-to-one tutorials as well as group tutorials in which potential approaches to publication / display will be considered.

How will I have the chance to evaluate the module?
